#### **Purpose**

The purpose of this Corporate Policy is to describe how Rightway Fasteners, Inc. determines external and internal elements that are relevant to its purpose and that affect the company's ability to achieve intended outcomes of our environmental management system.

### 4.1 Understanding the Organization and its context

- Cultural and social responsibility, and
- Use of best available technologies where financially feasible and practical.

In applying the above criteria and techniques Rightway Fasteners, Inc. will actively manage and implement programs, procedures, and its business plans to mitigate risk of pollution and/or harm to the environment and global climate change. These aspects will form the core strategy of Rightway Fasteners, Inc. when managing both its risks and opportunities for enhancing the local and global environment. These key strategies and management programs will form the core values of Rightway Fasteners, Inc. when implementing and managing its environmental management system. # 4.2 Understanding the needs and expectations of interested parties

Rightway Fasteners, Inc. Environmental Managers/Representatives (EMRs) will carry out regular reviews with regards to all interested parties whether internal or external. In doing so, Rightway Fasteners, Inc. EMRs will consider the needs and expectations of interested parties in terms of its overarching environmental strategy and performance. The RFI manufacturing facility will develop an Environmental Site Profile (ENV.522) to describe property boundaries, processes, equipment, chemical and waste storage capacities, and recycling activities as per procedure EMP1. These profiles will consider and document interested parties (*per ADM.206*) requirements relevant to a sites environmental management system, *items may include, but not limited to*;

- Federal, state and local regulatory agencies operation and reporting requirements,
- Customer reporting requirements,
- Internal reporting requirements,
- Employees,
- Contractors,
- Suppliers, and
- Local communities.

The Environmental Site Profiles are to be registered in the Rightway Fasteners, Inc. internal network and reviewed on an annual basis. The RFI EMS Managers/Representatives will document regulatory reporting requirements, customer reporting requirements, internal performance reporting, employee meetings, supplier reviews, contractor training and meetings with local community representatives on Environmental Calendar section of the EMS Performance Report each year (ENV.519). The Environmental Calendar, in conjunction with the Environmental Site Profile is the basis for the RFI facility's compliance obligations. The EMS Performance Report requirements are detailed in the EMP1 procedure.
